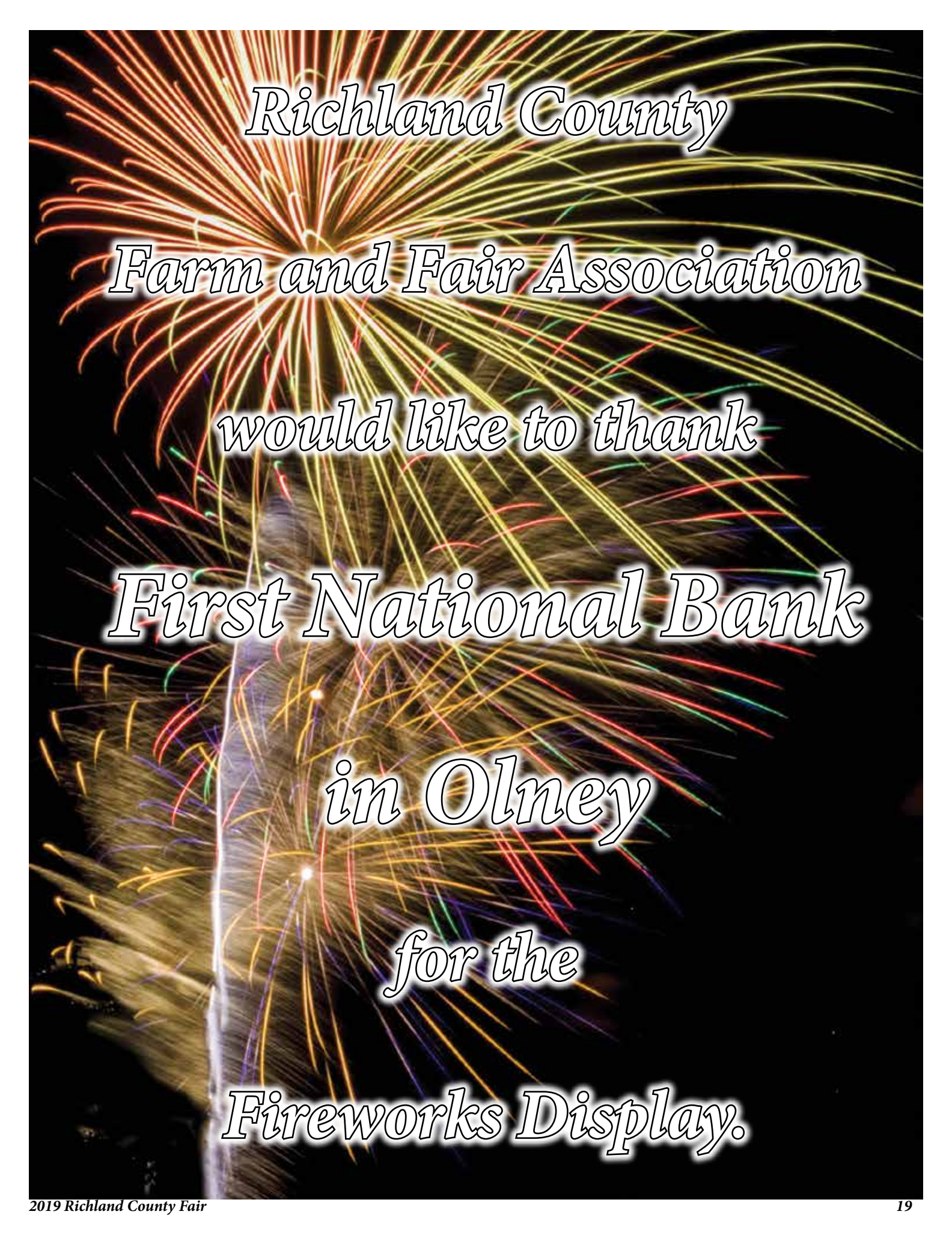

RULES AND REGULATIONS

Pursuant to "Act in relations to County and Agriculture Fairs, Fair and Exposition Fund Fairs and agricultural extension clubs, to make appropriations in connection therewith, and to repeal certain Sections of an Act therein named". "Approved August 20, 1971, these Rules and Regulations are promulgated".

Payment of State Aid Claims: No one department or class shall be paid State Aid on premiums awarded on excess of 30% of the total premiums awarded by the fair association. (Department of class, meaning Beef Cattle, Dairy Cattle, etc., as listed on the Grand Summary). The fair association will not be held responsible or subject to deduction in case of national disaster, boycott or act of God, applicable only to this regulation.

All gambling and gambling devices and the sale of alcoholic liquors are termed unlawful on the grounds of any County Fair or agricultural society. (Beer is excepted). The Fair officials will be held responsible for such violations. It is their duty to see that such violation does not exist. It is the responsibility of the local law enforcement officials to enforce all State Laws in relation to gambling. Gambling devices and the sale of alcohol liquors. (Beer is excluded).

The Department of Agriculture may deny State Aid to county fairs or other agricultural societies, participating in appropriation thereto, for violation of any provision herein and failure to comply with rules and regulations herein provided.

A protest of an award must be made in writing accompanied by an affidavit setting forth the grounds for protesting the award and deposit of \$50.00. In the event of the protest's being sustained, the \$50.00 will be returned to the complainant. If the protest is not sustained, the \$50.00 shall be forfeited to the association.

Exhibits are required to be in place on the opening day and remain for a period of five days, unless written permission has been granted by the Fair Association. Premiums will be paid on Friday, July 12, 2019 at 3:00 p.m. All Classes of Division II will be paid at the completion of the event.

Winners must pay entry fee prior to receipt of check on Friday for all of the following departments: Department A, Beef Cattle; Department B, Dairy Cattle; Department F Sheep; Department G, Swine except open Steer or Heifer and open Barrow/Gilt. Entry fees will be collected in all other departments at the time entry is made. The Exhibitors Ticket has been discontinued. Exhibitors Permit will be purchased by all exhibitors in Departments A, B, F, G and U at a fee of \$5.00 which covers administrative fees and gate pass. Additional car pass can be purchased for \$10.00.

The Fair Board of Directors reserves the right to open departments to individuals outside of adjacent counties is necessary to maintain quality of show in departments. Department Q, Tractor Pull and Truck Pull will be open to the world.

All registration papers must be in the name of the exhibitors. Papers with farm names or father and son or daughter is not acceptable. All livestock exhibited must be in the owners possession for at least 90 days prior to the Fair date.

The Fair Association reserves the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions and differences in regard thereto and add or amend these rules as they may deem advisable.

Camper fee for exhibitors and vendors: \$25.00 a day. All others by special permit.

STATE OF ILLINOIS DEPARTMENT OF AGRICULTURE

Reg. 1.53. These are permitted in connection with agricultural fairs only if they are open to boys and girls who are (8) eight years old, or in the third grade and not yet 19 years of age on or before September 1 of the year previous the fair. Rules and regulations in junior shows must, in most cases, be the same as those in the open show. Animals shown in junior Shows must be the property of the boys or girls showing them.

This can be proven by checking the registration papers. If these same animals are shown in the open classes, they must be shown in the same name. Thus the father is not permitted to show an animal in the open class and the son or daughter show the same animal in the Junior Show.

Reg. 1.54. Group showings or placings are not permitted. Herds or flocks cannot be made up of animals registered in the name of an older member of the family and shown by a son or daughter in the Junior Show.

Reg. 1.55. Fairs that are entirely Junior Shows and which do not have open classes will use the regular classes, mentioned herein, i.e., A Beef Cattle, etc. All classes of poultry, agricultural products, horticulture, floriculture, fine arts and textiles, dairy, apiary and culinary that are limited to the ages herein must show in Department P, unless they are showing in a strictly Junior Show fair, then again they will show in the property department as listed herein.

Reg. 1.56. In counties where the county board elects to have strictly a Junior Show and no county fair, livestock must be on the grounds on the opening date of the fair until the close of the fair unless otherwise instructed by the Department.

Reg. 1.57. Junior Show held prior to or after the opening classes must have separate and distinct classes and their dates must have prior approval of the Department.

The Following is a list of guidelines for all exhibitors and all livestock in competitive events:

1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age or any facts relating thereto is prohibited.

2. Owners, exhibitors, fitters trainers or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.

3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.

4. Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs are administered in accordance with federal, state and provincial statutes, regulation and rules effect the animal's performance or appearance at the event.

If the laboratory report on the analysis of saliva, urine, blood or other samples taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood or other substance tested by the laboratory to which it is sent is the one taken for the animal in question, its integrity is preserved and all procedures of said collection and preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer or absolutely responsible person to prove otherwise.

At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.

5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counter-irritant or similar substance) which could effect the animal's performance or alter its natural contour, confirmation or appearance, except external applications of substances to the hoofs or horns

of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.

6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance or other similar practices are not acceptable and are prohibited.

7. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.

8. No owner, exhibitor, fitter, trainer or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.

9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.

10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including fairs and Expositions and any special notices to members.

11. The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer or absolutely responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes regulation or rules may be released to appropriate law enforcement authorities and jurisdiction over such infractions.

2019 Exhibition Livestock Health Requirements
County Fairs

GENERAL REQUIREMENTS

These Exhibition Health Requirements apply to all livestock present at the fair including those animals that are not entered in competitive events.

1. Exhibitors are required to familiarize themselves with all rules applicable to their exhibits.

All out-of-state animals shall require an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782- 4944. Permits may also be obtained online

at: <http://www.agr.state.il.us/AnimalHW/animalregistry/login.php>

2. All animals, except as noted, shall be accompanied by a Certificate of Veterinary Inspection (CVI) which shows that the animal meets all health requirements for the State of Illinois. CVI's shall be made available to Bureau of Animal Health Personnel on request.

CVI means a legible record made on an official form from the state of origin which has been issued, signed and dated by an accredited veterinarian and which shows the name and address of the animal's owner or exhibitor and the results of all required tests or vaccinations. A CVI shall list only one animal identification per line; shall be presented on the form on which it was initially issued; and shall not be corrected, changed or altered in any manner.

3. All animals shall be officially identified. The animal(s) official identification shall be recorded on the CVI.
4. If animals are from tuberculosis accredited, brucellosis certified, pseudorabies qualified, or brucellosis validated herds, the identifying herd number(s) along with the date of the last herd test(s) shall appear on the CVI.
5. CVI for out-of-state livestock shall be void thirty (30) days after issuance.
6. CVI for Illinois-origin livestock shall be void ninety (90) days after issuance.
7. All livestock shall be subject to examination upon entry to any Illinois fair or exhibition. Any animal showing evidence of infectious, contagious or communicable diseases shall be immediately withdrawn and held in quarantine at the owner's risk and expense until properly treated and recovered, or until the animal is released to return to the owner's premise.

Any livestock infected with scabies, mange, active lesions of ringworm, soremouth, or multiple warts which are easily visible without close examination shall not be permitted to exhibit and are subject to quarantine or removal from the fairgrounds.

Sheep and goats with caseous lymphadenitis as evidenced by draining abscesses shall not be exhibited and are subject

to immediate quarantine or removal from the fairgrounds.

8. Illinois Department of Agriculture personnel or designee may collect blood, tissue, milk or urine samples from any animal being exhibited and/or raced at any Illinois fair to test for the presence of illegal drugs or banned substances. New examination techniques, such as ultrasound, may also be used at anytime while the animals are on the grounds of any Illinois fair or exhibit.

The Illinois Department of Agriculture or designee may collect urine, blood, tissue or other test samples from exhibition animals at the time of slaughter.

9. All exhibitors of animals at any Illinois fair or exhibition shall comply with the provisions of the Illinois Humane Care for Animals Act. If violations are observed, the animal(s) will be excused from exhibition and ordered removed from the grounds with all awards being forfeited.

Any practice or deviation from normal, accepted care, including physical, medical or mechanical application, shall constitute a violation of show rules and may result in the animal(s) disqualification and removal from the fairgrounds.

10. Any Illinois cattle, bison, cervidae or goats being exhibited in non-accredited free states must be isolated from the remainder of the herd/flock upon return to Illinois and retested for tuberculosis 60-120 days post-entry.

CATTLE

Individual identification of each animal shall be either a fully healed and legible tattoo, approved official ear tag, registration number (can only be used if the tattoo is recorded on the registration certificate or for breeds where pictures are acceptable), or individual brands, if brand is recorded on the registration certificate.

Illinois Cattle

Brucellosis

Illinois is a Bovine Brucellosis Class-Free State. Brucellosis testing is not required for Illinois cattle.

Tuberculosis

Illinois is an Accredited Tuberculosis- Free State. Tuberculin testing is not required for Illinois cattle.

Please note: Illinois calves under 6 months of age, and Illinois steers are not required to have a Certificate of Veterinary Inspection.

Out-of-State-Cattle

All out-of-state cattle are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: <http://www.agr.state.il.us/AnimalHW/animalregistry/login.php>

Brucellosis

1. Female cattle six (6) months of age and older and bulls eighteen (18) months of age and older shall be negative to an official test for brucellosis within thirty (30) days prior to entry, unless exempt by one (1) of the following:
 - A. Originate directly from a certified brucellosis-free herd.
 - B. Official vaccinates of dairy breeds under twenty (20) months of age or official vaccinates of beef breeds under twenty-four (24) months of age.
 - C. Animal originated from a "Class Free" state (if entire state is so classified)
 - D. Steers and spayed heifers are not required to be tested for brucellosis.
2. The negative brucellosis test shall be conducted at a state or federal laboratory within 30 days prior to exhibition.

Tuberculosis

1. Accredited Tuberculosis Free States
 - A. No tuberculin test required. All cattle, including steers, originating from an Accredited Tuberculosis Free State, may enter Illinois for exhibition when accompanied by a CVI issued by an accredited veterinarian within 30 days.
2. Non-Accredited Tuberculosis Free Areas or States (Not TB-Free)
 - A. Cattle must originate from a herd where a complete herd test was conducted within the past year.
 - B. The individual animals entering Illinois must be negative to an additional tuberculin test conducted **within 30 days prior to exhibition**.
 - C. Cattle that enter Illinois for exhibition and remain in Illinois (animal does not return to the state of origin within 30 days) must be isolated and retested for TB 60-120 days from the last official TB test date.

SWINE

Illinois Swine

Identification

1. Swine shall be identified by an official ear tag, tattoo or recognized breed ear notch.
2. Ear notch identification is acceptable for all barrows, crossbred gilts and breeding swine. **(Note: Ear notch identification of crossbred swine does not satisfy USDA identification requirements for interstate movement or official testing.)**

Brucellosis

Brucellosis testing is not required for Illinois swine.

Pseudorabies

Pseudorabies testing is not required for Illinois swine.

Out-of-State Swine

All out-of-state swine are to be accompanied by an entry permit.

Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: <http://www.agr.state.il.us/AnimalHW/animalregistry/login.php>

Identification

1. Individually identified by an official ear tag, tattoo or recognized breed ear notch.
2. Ear notch identification **is not** acceptable for crossbred animals.

Brucellosis

1. Breeding swine 4 months of age and older shall be negative to an official test for brucellosis within 30 days prior to exhibition unless exempt by one (1) of the following:
 - A. Originate immediately and directly from a validated brucellosis-free herd.
 - B. Originate directly from a validated brucellosis-free state.
2. Swine brucellosis tests for exhibition shall be conducted at a state or federal laboratory.

Pseudorabies

1. **Swine originating from a Pseudorabies Stage IV or V state are exempt from the pseudorabies testing requirement.**
2. Swine originating from a Pseudorabies Stage III state shall be negative to an official test for pseudorabies conducted within thirty (30) days prior to entry or originate immediately and directly from a qualified pseudorabies negative herd.
3. Swine originating from a Pseudorabies Stage I or II state shall be negative to an official test for pseudorabies conducted within the 10 days prior to entry.
4. Barrows and females in market classes must meet the same requirements as breeding swine.

SHEEP

Individual identification of each animal shall be by an ear tattoo or official metal or plastic tag. A microchip ID is acceptable if the owner provides the reader.

Ear tattoos may be used when a registration certificate, listing the tattoo number, accompanies the animal.

When using ear tags, the tag must indicate the premises ID and state of origin. The tag number must be assigned by a state or APHIS representative and recorded in the Scrapie Record Database.

Market Lambs

All market lambs must be slick shorn (show ring ready) before weigh-in so that show lamb fungus can be identified.

Illinois Sheep

1. Sheep originating from a flock that has previously been classified as either an infected or source flock can be exhibited in Illinois upon the completion of an approved flock plan.

2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

Out-of-State Sheep

All out-of-state sheep are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: <http://www.agr.state.il.us/AnimalHW/animalregistry/login.php>

1. Sheep originating from a flock that has previously been classified as either an infected or source flock can be exhibited in Illinois upon the completion of an approved flock plan.
2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

GOATS

Individual identification of each animal shall be by an ear tattoo or official metal or plastic tag. A microchip ID is acceptable if the owner provides the reader.

Tattoos may be used when a registration certificate, listing the tattoo number, accompanies the animal.

When using ear tags, the tag must indicate the premises ID and state of origin. The tag number must be assigned by a state or APHIS representative and recorded in the Scrapie Record Database.

Ears should be used for tattooing when possible. If there is no space in the ear, the flank or tail fold may be used.

Illinois Goats

1. Goats originating from a herd that has previously been classified as either an infected or source herd can be exhibited in Illinois upon the completion of an approved herd plan.
2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin,
3. if different.

Out-of-State Goats

All out-of-state goats are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online

at: <http://www.agr.state.il.us/AnimalHW/animalregistry/login.php>

1. Goats originating from a herd that has previously been classified as either an infected or source herd can be exhibited in Illinois upon the completion of an approved herd plan.
2. Tuberculosis- Goats from areas or states that are not Accredited Bovine Tuberculosis Free, must be accompanied by a CVI indicating that the goats originated from a herd where a complete negative herd test has been conducted within the past twelve (12) months and the individual animals are negative to a tuberculin test conducted within thirty (30) days prior to entry. For any animal born after 1/1/2002, the CVI must include the flock of birth and the

flock of origin, if different.

HORSES, PONIES, MULES AND OTHER EQUIDAE

Illinois Equine All horses and other equidae, twelve (12) months of age and older attending an advertised equine event, shall be accompanied by a negative test for equine infectious anemia (EIA) conducted within the last twelve (12) months. A copy of this test shall accompany the animal.

1. AGID (Coggins) or ELISA tests are accepted.
2. An advertised equine event means a show, rodeo, sale, auction, exhibition, trail ride, or horse fair that is posted or media promoted.
3. A CVI is not required for Illinois equine.

Out-of-State Equine

All out-of-state equine are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: <http://www.agr.state.il.us/AnimalHW/animalregistry/login.php>

1. All horses and other equidae entering Illinois that are twelve (12) months of age or older, shall be accompanied by a negative test for equine infectious anemia (EIA) conducted within the last twelve (12) months. A copy of this test shall accompany the animal.
2. AGID (Coggins) or ELISA tests are accepted.
3. All horses and other equidae shall be accompanied by a CVI issued within thirty (30) days prior to entry.

POULTRY

Please Note the 2019 Pullorum Testing Waiver at the End of This Document.

All entries (except waterfowl, i.e. domesticated fowl that normally swim, such as ducks and geese) in a show or exhibition shall have originated from a U.S. Pullorum-Typhoid Clean or equivalent hatchery or flock OR have a negative pullorum-typhoid test within 90 days prior to exhibition. Exhibitor shall show proper information as to name and address of owner or exhibitor, name and address of the authorized testing agent, date of the testing and the number, breed, and species of those tested.

1. Prior to being used to transport poultry to a show, all crates, boxes, containers and vehicles shall be thoroughly cleaned and disinfected.
2. Any poultry vaccinations must be performed at least 4 weeks prior to delivery to the show.
3. Upon admission to a show, all entries shall be examined by the official county fair veterinarian or qualified state personnel who shall also receive and examine all certificates necessary for admission of birds to a show. Birds not in show condition will be excused from exhibition and removed from the premises. Any fowl showing signs of illness during the fair will be removed from the exhibition grounds.
4. All out-of-state turkeys must originate from flocks that are officially classified as U.S. Mycoplasma Gallisepticum Clean in accordance with the provisions of the National

Poultry Improvement Plan or be negative to a test for *Mycoplasma gallisepticum* within 30 days prior to entry.

5. A permit is also required for out-of-state poultry. A permit may be obtained by calling (217)782-4944.

Please note: These poultry exhibition requirements do not apply to 4-H and FFA 1-day poultry shows where the entries are taken to the show and returned home the same day. However, a permit is required for out-of-state poultry.

CERVIDAE

(Deer, Elk, Reindeer, Caribou, Moose, Red Deer and other Related Species)

Identification

All animals shall be individually identified with an approved tag, microchip or tattoo. Elk are required to have two official/approved unique identifiers.

Illinois Cervidae

Chronic Wasting Disease

For cervidae changing ownership or moving within the State, the owner must obtain a permit issued by the Department prior to movement and the cervid must originate from a herd that is enrolled in the Certified Monitored Chronic Wasting Disease (CWD) Program or the Contained Monitored Chronic Wasting Disease Program. The permit shall be obtained no more than 72 hours in advance of the movement of the cervids by providing the following information:

- A) Name and complete mailing address of person exhibiting the cervids;
- B) Certified Monitored Chronic Wasting Disease or Contained Monitored Chronic Wasting Disease Herd number;
- C) Name and complete mailing address of location where the animals will be exhibited;
- D) Number of animals and unique identification of the animals.

Tuberculosis

Illinois is an Accredited Tuberculosis-Free State. Tuberculin test is not required for Illinois cervidae.

Out-of-State Cervidae

Chronic Wasting Disease

1. All cervidae entering Illinois must be in compliance with the Illinois Wildlife Code [520 ILCS 5]. For more information, contact the Illinois Department of Natural Resources at 217/782-6384.
2. All cervidae entering Illinois must be accompanied by a permit from the Department and a Certificate of Veterinary Inspection that:
 - a. has been issued by an accredited veterinarian of the state of origin or a veterinarian in the employ of the United States Department of Agriculture;
 - b. is approved by the Animal Health Official of the state of origin;

- c. shows that the cervidae are free from visible evidence of any contagious, infectious or communicable disease or exposure thereto, do not originate from a CWD endemic area (any county and surrounding counties where CWD has been diagnosed in the past five years);
 - d. shows that the cervidae are not originating from a herd under quarantine for any contagious, infectious or communicable disease;
 - e. shows that the animals originate from a herd that has been monitored for at least 5 years under a state-approved CWD certification program.
3. A permit number can be obtained by calling (217) 782-4944. Applicant for permit shall furnish the following information to the Department:
 - a. Name and post office mailing address of Illinois destination;
 - b. Name and post office mailing address of the consignor and/or source herds;
 - c. Name and post office mailing address of the herd veterinarian;
 - d. Number and unique identification of cervidae in shipment.

Brucellosis

Cervidae six (6) months of age and older must have a negative brucellosis card or PCFIA test within sixty (60) days prior to entry.

Tuberculosis

1. Accredited Tuberculosis Free States

All cervidae twelve (12) months of age and over shall be negative to two (2) single cervical test for bovine TB no less than ninety (90) days apart with the second test conducted within ninety days prior to entry. These animals shall be isolated from all other members of the herd during the testing period unless they originate from an accredited, qualified or monitored herd.

- A. Cervidae from an accredited herd may be moved into Illinois without further TB testing provided that a certificate stating that such cervids originated from an accredited herd accompanies them.
 - B. Cervidae originating from qualified or monitored herds may enter with a negative test within ninety (90) days prior to entry and a certificate stating that the animals originate from a monitored herd.
2. Non-Accredited Tuberculosis Free Areas or States (Not TB-Free)
 - A. All cervidae shall originate from a herd where a complete herd test was conducted within the past year.
 - B. The individual animals entering Illinois must be negative to two (2) additional tuberculin tests conducted within 180 and 30 days prior to entry or exhibition.

RATITES

(Ostriches, Emus, Rheas, Cassowaries and Kiwis)

Illinois Ratites

There are no requirements governing the movement of ratites within Illinois.

Out-of-State Ratites

1. Must be accompanied by a CVI and permit number. Entry permits are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944.
2. Individually identified by leg band or microchip.
3. Negative test for Avian Influenza within 10 days prior to entry.

PIGEONS

There are no requirements governing the movements of pigeons within or into Illinois.

RABBITS

There are no requirements governing the movements of rabbits within or into Illinois.

LLAMAS

There are no requirements governing the movement of llamas within Illinois. A permit and health certificate is required for out-of-state llamas. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at (217) 782-4944.

Permits may also be obtained online at: <http://www.agr.state.il.us/AnimalHW/animalregistry/login.php>

Salmonella Pullorum Testing Waiver

The Illinois Poultry Inspection Act, (510 ILCS 85/2.1), states that no hatching eggs or poultry, except poultry for immediate slaughter, shall be bought, sold, transported within or imported into the State unless the hatchery or flock of origin is a participant in the National Poultry Improvement Plan for the eradication of pullorum and fowl typhoid, or is following a program officially approved by the Department. The Administrative Rules (8 Ill. Adm. Code Section 55.70) state that all entries (except waterfowl, i.e., domesticated fowl that normally swim, such as ducks and geese) to a show or exhibition must have come from a *U. S. pullorum- typhoid clean* or equivalent hatchery or flock; or have a negative pullorum-typhoid test within 90 days prior to exhibition. It should be noted that the United States has not reported Pullorum- Typhoid in the last ten years.

Due to the shortage of antigen necessary to conduct Pullorum-Typhoid testing, the State of Illinois is waiving the pullorum requirements for birds or hatching eggs sold within or imported into the State as well as the testing requirements for exhibition. Once antigen becomes available, this waiver will be rescinded and all flocks participating in the National Poultry Improvement Plan will be required to conduct their annual test. Reciprocity with other states is not guaranteed and producers / exhibitors are responsible for contacting those state officials regarding compliance with entry requirements.

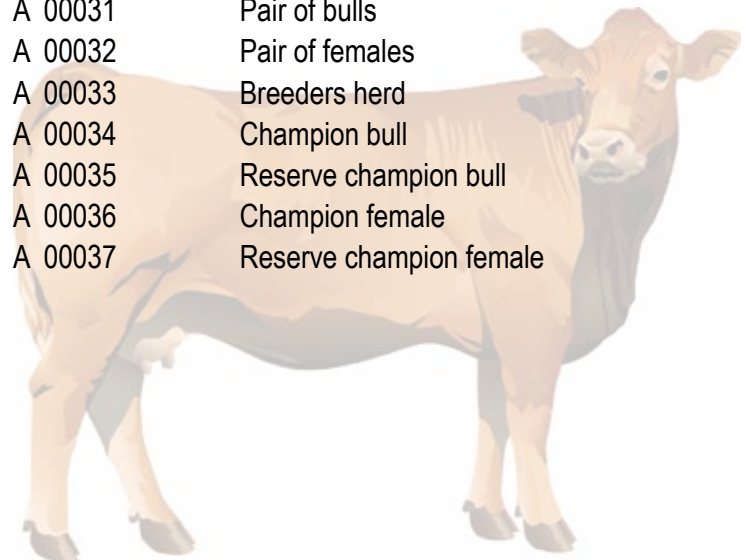

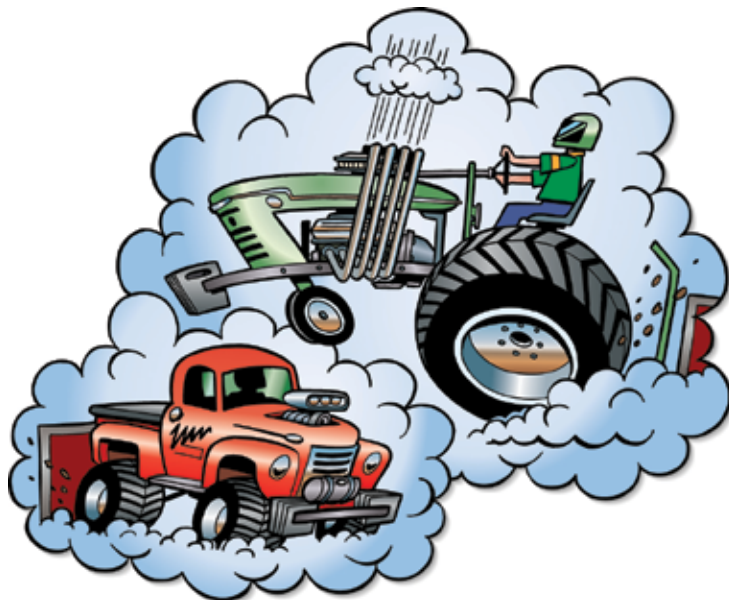

ILLINOIS DEPARTMENT of Public Health

Policies and precautions of the division of Foods and Dairies covering Mobile and Itinerant Food Service Establishments:

These policies and procedures are designed to cover mobile or temporary/stationary food service establishments such as food and beverage vending stands, mobile food or beverage vehicular trailers or trucks or temporary food service establishments found at State and County fairs, carnivals, large picnics, festivals, athletic events, etc.

Where such food service establishments come under the jurisdiction of a full-time accredited health department which has ordinances requiring sanitary conditions equivalent to or stricter than Illinois Uniform Food Act and the accredited health departments shall inspect and license such food service establishments.

In areas other than those covered above the personnel of the Illinois Department of Public Health's Division of Food and Dairies shall inspect the food service establishments above described.

It shall be the duty of the operators, owners or proprietors of all these food service establishments to comply fully with both the State and local Laws, Rules and Regulations from the State stand-point, recommended precautions covering the dispensing of food and drink at State and County fairs and other similar public gatherings is attached. Local Health Departments may require stricter regulations and should be consulted wherever they have pertinent ordinances.

Temporary Food Service Establishment Regulations

The following items are required for compliance with the Illinois Department of Public Health's Food Service Sanitation Rules and Regulations pertaining to operation of a temporary food service facility at fairs, carnivals and other public gatherings.

1. Food Supplies: All Food supplies, including meat, milk, vegetables, etc., shall be obtained from sources complying with applicable State Laws and Regulations. All food shall be clean, wholesome, free from adulteration and misbranding. Home-canned foods will not be permitted. All fruits and vegetables shall be washed before being used. Food stands which freeze dairy

products must have a "Certificate of Approval" from the Division of Food and Drugs.

2. Personal Hygiene: Personnel with boils, cuts, respiratory infections and communicable diseases shall not be permitted to work in a food stand. Fingernails shall be trimmed, hands and arms shall be washed and clean before starting work, washed after visiting the toilet and washed as frequent as necessary during the day. Employees shall wear clean outer clothing. All female employees shall wear hairnets. Male employees shall wear caps and if hair is kept long, a hairnet shall be worn also. Smoking or other use of tobacco is not permitted by food stand personnel in food preparation or sales areas.

3. Handwashing Facilities: Convenient and adequate handwashing facilities shall be provided in each establishment. The minimum shall consist of a pan, water, soap and individual towels. Common towels are prohibited.

4. Menu Restrictions and Food Preparation: Potentially hazardous food such as cream-filled pastries, custards, cream pies and meat, poultry and fish in the form of salads or sandwiches shall be prohibited. The proceeding does not apply to hamburgers, frankfurters and other food which, prior to serving, requires just seasoning and cooking.

Fresh pork and poultry must be heated throughout to a minimum internal temperature of 165°. Chicken pies, chicken fricassee and chicken and noodles shall not be prepared or served.

All hamburgers intended for use in sandwiches shall be purchased in patty form only. Hams, including "pre-cooked", shall be thoroughly cooked prior to serving. Potato salad shall not be prepared or served. Left over potentially hazardous food, including sandwiches, shall not be offered for sale the following day.

5. Refrigeration and Food Temperature: Potentially hazardous food, which consists in whole or in part, of milk or milk products, eggs, meat, poultry and fish shall be maintained at temperatures of 45°F or below, or 140°F or above. Only mechanical refrigeration shall be permitted for maintaining refrigeration temperatures.

6. Food and Drink Storage and Display: All food supplies shall be stored off the ground, on pallets or shelves. All food shall be properly covered to prevent contamination, etc.

Wet storage of packaged food and beverages is prohibited. Pressurized containers of soft drinks may be stored in ice water if the water contains at least 50ppm of available chlorine and if the water is changed often enough to keep both the water and the containers clean.

All food on display, such as cotton candy, candied apples, etc., shall be covered or be individually packaged to prevent contamination from dust and other elements.

7. Condiment: Sugar, mustard, catsup and other condiments shall be individually packaged or dispensed from an approved dispenser.

8. Ice Supply and Handling: Ice that is consumed or which will come in contact with food shall be obtained from an approved source in chipped, crushed or cubed form, transported and stored in single service, closed container bags. Bagged ice shall not be stored directly on the ground.

Containers for storage of ice on location shall be constructed of easily cleanable materials, equipped with a drain and provided with overlapping tight-fitting covers. Dippers or scoops shall be used in dispensing of ice. Hand dipping of ice is prohibited.

9. Water Supply and Storage. An adequate supply of sanitary drinking water, food preparation, handwashing and cleaning utensils and equipment shall be provided in the food stand. Wherever possible, a pressure supply system is recommended. Hot water shall be made available for cleaning purposes.

10. Multi-Use Eating and Drink Utensils: The manual washing of plates, glasses, cups and silverware is prohibited. Only single service tableware and utensils shall be used, including cups, plates and eating utensils. Facilities shall be provided for washing pots, pans and similar utensils.

All single service articles shall be properly stored to prevent contamination of surfaces in contact with the mouth of a customer. Only individually wrapped drinking straws shall be used.

11. Food Equipment, Construction and Cleanliness: Only food equipment that is in good repair and cleanable shall be used. Food-contact surfaces shall be corrosion resistant, nonabsorbent, non-toxic, free of breaks, open seams, chips, pits and similar imperfections.

Galvanized containers shall not be used for preparation, display and storage of acid drinks. Appropriate scoops, tongs, spoons and forks shall be provided to minimize manual contact with food.

After each usage, all kitchenware and food contact surfaces of equipment, exclusive cooking surfaces, used in preparing, serving, display or storage of foods, shall be thoroughly cleaned to sight and touch. All counters and shelvings shall be kept clean and presentable at all times.

12. Liquid and Solid Waste Disposal: All liquid waste shall be disposed into public sewers in such a manner as not to create a public health hazard or nuisance condition.

An adequate number of approved garbage containers with tight-fitting lids shall be provided at each stand.

It shall be the responsibility of each food stand owner or operator to keep the grounds surrounding their stand free of food scraps, paper and other debris.

13. Food Stand Construction: Kitchen and food preparation areas shall have ceilings and sides so constructed as to minimize

the entrance of insects and dust. Ceilings and sides may be wood, canvas or other materials which will protect the interior of food stand from the elements.

Effective shielding shall be provided consisting of glass or other durable materials where necessary to prevent contamination of food and food preparation equipment from dust, rain, flies, insects, consumer handling and other elements. These restrictions also apply to concessionaires distributing free food samples.

Kitchen and food preparation area not located on concrete or asphalt surfaces shall have temporary flooring constructed of wood and elevated to prevent contamination of food by dust, mud, etc. Sawdust shall not be used as a floor covering. Flooring in outdoor permanent stands shall be maintained in good repair.

All wood framing shall be freshly painted, in good repair and maintained in a clean condition. All canvas shall be in good repair and maintained in a clean condition.

The proceeding will be subject to approval by the inspection agency when the food stand is assembled.

14. Utilization of Food Service Facilities Located Off the Fairground: Facilities such as church kitchens and commercial restaurant, etc., which are utilized for off the grounds preparation of food served at the fair shall meet the Food Service Sanitation Regulation of the Illinois Department of Public Health.
